Foster by deed recorded in Official Record 9256E04 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

BEGINNING at the northwest corner of said Lot No. 254, being at the intersection of the south right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the east right of way line of Eureka Avenue (60' public right of way), from which point a found 3/4" iron pipe bears N11°26'10"W, 1.50';

thence along the north line of said Lot No. 254 and the south right of way line of said Mound Street, South seventy-six degrees forty-five minutes fifty-seven seconds East (S76°45'57"E) for one hundred forty-five and 1/100 feet (145.01') to the northeast corner of said Lot No. 254, being the intersection of the south right of way line of said Mound Street with the west right of way line of the 1st Alley West of Wayne Avenue (16' public right of way);

thence along the east line of said Lot No. 254 and the west right of way line of said Alley, South thirteen degrees five minutes three seconds West (\$13°05'03"W) for five and 00/100 feet (5.00');

thence leaving said lines across said Lot No. 254, North seventy-six degrees forty-five minutes fifty-seven seconds West (N76°45'57"W) for one hundred forty-five and 1/100 feet (145.01') to the west line of said Lot No. 254 and the east right of way line of said Eureka Avenue;

thence along said lines, North thirteen degrees five minutes three seconds East (N13°05'03"E) for five and 00/100 feet (5.00') to the **POINT OF BEGINNING**, containing 0.0166 acres (725.0 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
