BEGINNING at the southwest corner of said Lot No. 253, being at the intersection of the north right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the east right of way line of Eureka Avenue (60' public right of way), from which point a found 3/4" iron pipe bears N19°07′51"E, 1.35';

thence along the west line of said Lot No. 253 and the east right of way line of said Eureka Avenue, North thirteen degrees five minutes three seconds East (N13°05'03"E) for six and 00/100 feet (6.00');

thence leaving said lines across said Lot No. 253, South seventy-six degrees forty-five minutes fifty-seven seconds East (S76°45'57"E) for one hundred twenty-one and 32/100 feet (121.32');

thence continuing across said Lot No. 253, North thirteen degrees fifty-four minutes forty-four seconds East (N13°54'44"E) for four and 00/100 feet (4.00');

thence continuing across said Lot No. 253, South seventy-six degrees forty-five minutes fifty-seven seconds East (S76°45'57"E) for twenty-three and 63/100 feet (23.63') to the east line of said Lot No. 253 and the west right of way line of the 1st Alley West of Wayne Avenue (16' public right of way);

thence along said lines, South thirteen degrees five minutes three seconds West (\$13°05'03"W) for ten and 00/100 feet (10.00') to the southeast corner of said Lot No. 253, being the intersection of the north right of way line of said Mound Street with the west right of way line of said Alley;

thence along the south line of said Lot No. 253 and the north right of way line of said Mound Street, North seventy-six degrees forty-five minutes fifty-seven seconds West (N76°45'57"W) for one hundred forty-five and 1/100 feet (145.01') to the **POINT OF BEGINNING**, containing 0.0221 acres (964.7 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
