## TEMPORARY CONSTRUCTION EASEMENT PARCEL 54-T2 0.0075 ACRE TRACT (325.4 S.F.) EXHIBIT "A"

Situate in the City of Columbus, County of Franklin, State of Ohio, Virginia Military Survey No. 971, being part of Lot No. 206 of Westland Addition Extension Subdivision as recorded in Plat Book 18, Page 40 and conveyed to S & S Properties by deed recorded in Official Record 8711116 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

Commencing for reference at the northeast corner of said Lot No. 206, being at the intersection of the south right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the west right of way line of Wayne Avenue (60' public right of way);

thence along the east line of said Lot No. 206 and the west right of way line of said Wayne Avenue, South thirteen degrees five minutes three seconds West (\$13°05'03"W) for nine and 84/100 feet (9.84') to the **TRUE POINT OF BEGINNING** of the herein described tract of land;

thence continuing along said lines, South thirteen degrees five minutes three seconds West (\$13°05'03"W) for fifteen and 44/100 feet (15.44');

thence leaving said lines across said Lot No. 206 for the following four (4) courses:

- 1. North seventy-six degrees forty-one minutes forty-two seconds West (N76°41'42"W) for one and 09/100 feet (1.09');
- 2. North fifty degrees thirty-two minutes seven seconds West (N50°32'07"W) for twelve and 93/100 feet (12.93');
- 3. North sixteen degrees fifty-eight minutes eight seconds West (N16°58'08"W) for sixteen and 66/100 feet (16.66');
- 4. North thirteen degrees fourteen minutes three seconds East (N13°14'03"E) for five and 17/100 feet (5.17') to the north line of said Lot No. 206 and the south right of way line of said Mound Street;

thence along said lines, South seventy-six degrees forty-five minutes fifty-seven seconds East (S76°45'57"E) for seven and 06/100 feet (7.06');

thence leaving said lines across said Lot No. 206 for the following three (3) courses:

- 1. South thirteen degrees five minutes three seconds West (S13°05'03"W) for three and 00/100 feet (3.00');
- 2. South seventy-six degrees fifty-four minutes fifty-seven seconds East (S76°54'57"E) for seven and 07/100 feet (7.07');

3. South thirty-one degrees fifty-four minutes fifty-seven seconds East (S31°54'57"E) for nine and 73/100 feet (9.73') to the **TRUE POINT OF BEGINNING**, containing 0.0075 acres (325.4 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
