## TEMPORARY CONSTRUCTION EASEMENT (5-T)

(Grantor: Mark Moxley and Annette Moxley)

Situated in the State of Ohio, County of Franklin, City of Columbus, Third Quarter of Township 1, Range 17, United States Military Lands, located in part of Lot 18 of the Theodore Leonard's Heirs Subdivision, being 0.015 acre out of the tract conveyed to Mark Moxley and Annette Moxley in Instrument Number 199611060224234 (further shown upon the attached exhibit), and being described as follows:

**Commencing** at the intersection of the centerline of Woodward Avenue (60' in width) and the centerline of Brentnell Avenue (variable width);

Thence South  $86^{\circ} 18' 41''$  East, along the said centerline of Woodward Avenue, a distance of 1017.78 feet to a point;

Thence North  $03^{\circ} 41' 19''$  East, leaving the aforesaid centerline, a distance of 30.00 feet to a point in the northerly right-of-way line of said Woodward Avenue, being the southeasterly corner of the tract conveyed to Tabernacle Baptist Church in instrument 199308030184020, being the **Point of Beginning** for the herein described easement;

Thence continuing North  $03^{\circ} 41' 19''$  East, along the easterly line of the said Tabernacle Baptist Church tract, a distance of 5.00 feet to a point;

Thence South  $86^{\circ} 18' 41''$  East, through the said Mark Moxley and Annette Moxley tract, a distance of 126.45 feet to a point in the westerly line of the tract conveyed to Cloudy H. Williams in instrument 200810290159274;

Thence South  $03^{\circ} 41' 19''$  West, along the said westerly line of the Cloudy H. Williams tract, a distance of 5.00 feet to a point in the said northerly right-of-way line of Woodward Avenue, being the southwesterly corner of the aforesaid Cloudy H. Williams tract;

Thence North  $86^{\circ} 18' 41''$  West, along the said northerly right-of-way line of Woodward Avenue, a distance of 126.45 feet to the **Point of Beginning**.

Containing 0.015 acre, more or less, out of Franklin County Auditor's Parcel No. 010-093974.

Subject to all other existing and valid easements, restrictions and conditions, if any.

Bearings are established to the Ohio State Plane Coordinate System – South Zone (NAD83) using GPS observations performed in July 2015 with a bearing of South  $86^{\circ} 18' 41''$  East along the centerline of Woodward Avenue, and all other bearings calculated from this meridian.

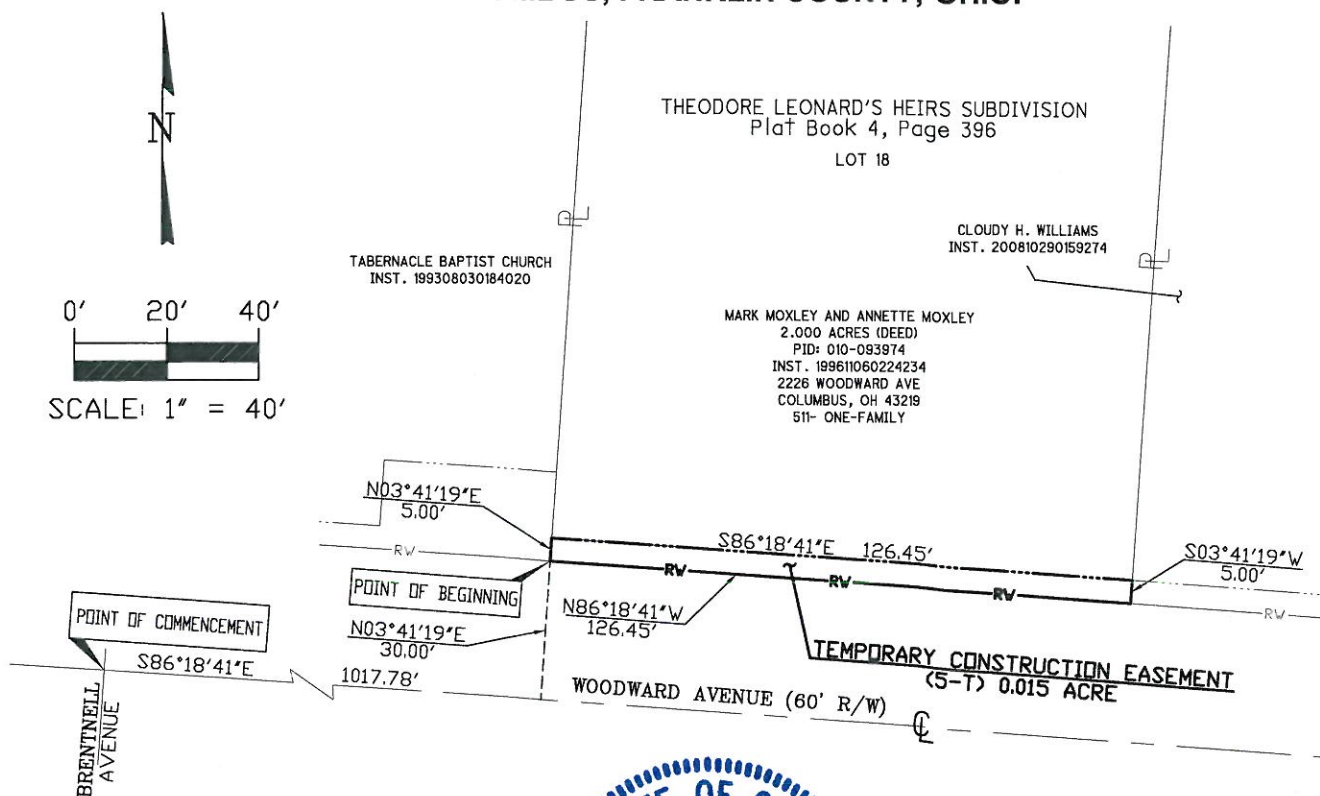
