The following investigation was conducted concerning the City of Columbus' 2016 – 2017 annual objection to the renewal of liquor permit held by AM Sunoco, Inc. doing business as Sunoco located at 2825 Olentangy River Rd. Columbus, Ohio. After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been complied with regard to the objection to the renewal of the permit issued to AM Sunoco, Inc. doing business as Sunoco located at 2825 Olentangy River Rd. Columbus, Ohio by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the Division of Liquor Control # 0151200. The permit holder received a C - 1 permit, a C - 2 permit, and a D - 6 permit. These permits grant the permit holder the privilege to sell alcoholic beverages in the State of Ohio for off premise consumption as described by law.

An "Inquiry of Liquor Violations" was received from the State of Ohio, Division of Liquor Control. The "Inquiry of Violations" revealed that the permit holder has received the following violations:
