Management Summary

Project Background & Objectives

The Department of Development for City of Columbus has various departments under its jurisdiction that perform multiple paper based processing. The Department of Development currently does not have any system that is a repository for their "single source of truth". Currently, the Department of Development utilizes E-Property Plus as their web based solution to store and access information for their processes.

Based on the conversations 3SG PLUS had with the Department of Development so far, below is an understanding of a high level approach to the solution that will address the needs. The Department of Development requires document scanning, search and retrieval. 3SG PLUS has proposed an implementation estimate for this project (with the use of OnBase).

Assumptions

Due to our experience creating solutions for similar challenges, 3SG PLUS estimates the following items when creating our budgetary estimates:

- Configuration of 3 scan gueues
- 10 document types (maximum of 15 keywords in each)
- This solution is only a scan, store and retrieve system.
