Thence northeasterly, crossing the said property, North 33°15'58" East, 25.56 feet to a point being 39.88 feet right of centerline of right of way of Georgesville Road station 124+37.73;

Thence northwesterly, crossing the said property, North 35°46'07" West, 6.64 feet to a point being 35.36 feet right of centerline of right of way of Georgesville Road station 124+42.60;

Thence northerly, with a curve to the right, having a radius of 23.00 feet, a central angle of 44°24'29", an arc length of 17.83 feet, and a chord that bears North 13°33'53" West, 17.39 feet to a point being 29.22 feet right of centerline of right of way of Georgesville Road station 124+58.87;

Thence northerly, crossing the said property, North 8°38'22" East, 1.08 feet to the southerly line of a 19 foot "Trail Easement" as conveyed to the Board of Park Commissioners of the Columbus and Franklin County Metropolitan Park District of record in Instrument Number 201309300165229 and being 29.25 feet right of centerline of right of way of Georgesville Road station 124+59.95;

Thence northeasterly, along the said 19 foot "Trail Easement", North 54°43'16" East, 2.78 feet to a point being 31.30 feet right of centerline of right of way of Georgesville Road station 124+61.82;

Thence southerly, crossing the said property, South 8°38'22" West, 3.01 feet to a point being 31.22 feet right of centerline of right of way of Georgesville Road station 124+58.81;

Thence southerly, with a curve to the left, having a radius of 21.00 feet, a central angle of 44°24'29", an arc length of 16.28 feet, and a chord that bears South 13°33'53" East, 15.87 feet to a point being 36.82 feet right of centerline of right of way of Georgesville Road station 124+43.96;

Thence southeasterly, crossing the said property, South 35°46'07" East, 8.00 feet to a point being 42.27 feet right of centerline of right of way of Georgesville Road station 124+38.10;

Thence southerly, with a curve to the right, having a radius of 19.00 feet, a central angle of 59°50'23", an arc length of 19.84 feet, and a chord that bears South 5°50'56" East, 18.95 feet to a point being 46.52 feet right of centerline of right of way of Georgesville Road station 124+19.63;

Thence southerly, with a curve to the left, having a radius of 36.00 feet, a central angle of 25°47'11", an arc length of 16.20 feet, and a chord that bears South 11°10'41" West, 16.06 feet to a point being 45.38 feet right of centerline of right of way of Georgesville Road station 124+03.60;

Thence southerly, crossing the said property, South 1°42'55" East, 10.22 feet to the southerly existing right of way of the said railroad subject property and being 46.95 feet right of centerline of right of way of Georgesville Road station 123+93.51;

Thence southwesterly, along the said southerly existing right of way of the railroad subject property, South 54°43'16" West, 29.71 feet to the Point of Beginning, containing 0.014 acres (588.1 S.F.), more or less.

Subject to all legal rights of way and/or easements, if any, of previous record.

The bearings on this plan are based on the Ohio State Plane Coordinate System, South Zone, NAD83 (2011). Said bearings originated from a field traverse which was referenced to the said coordinate system by GPS observations and observations of selected stations in the Ohio Department of Transportation Virtual Reference Station Network. The portion of the centerline of Georgesville Road having a bearing of North 7°06'40" East, is designated the "Basis of Bearing" for this description.

All stations and offsets are referenced to the centerline of existing right of way as found on plans named "Sullivant/Georgesville Camp Chase Trail Connector" as filed with the City of Columbus and designated as "3194-E".
