Thence northerly, with a curve to the left, having a radius of 31.00 feet, a central angle of 59°50'23", an arc length of 32.38 feet, and a chord that bears North 5°50'56" West, 30.93 feet to a point being 51.06 feet right of centerline of right of way of Georgesville Road station 124+46.27;

Thence northwesterly, crossing the said property, North 35°46'07" West, 8.00 feet to a point being 45.62 feet right of centerline of right of way of Georgesville Road station 124+52.13;

Thence northerly, with a curve to the right, having a radius of 9.00 feet, a central angle of 44°24'29", an arc length of 6.98 feet, and a chord that bears North 13°33'53" West, 6.81 feet to a point being 43.21 feet right of centerline of right of way of Georgesville Road station 124+58.49;

Thence northerly, crossing the said property, North 8°38'22" East, 14.56 feet to the southerly line of a 19 foot "Trail Easement" as conveyed to the Board of Park Commissioners of the Columbus and Franklin County Metropolitan Park District of record in Instrument Number 201309300165229 and being 43.60 feet right of centerline of right of way of Georgesville Road station 124+73.05;

Thence northeasterly, along the said 19 foot "Trail Easement", North 54°43'16" East, 23.49 feet to a point being 60.95 feet right of centerline of right of way of Georgesville Road station 124+88.88;

Thence southerly, crossing the said property, South 4°04'08" East, 20.31 feet to a point being 64.89 feet right of centerline of right of way of Georgesville Road station 124+68.96;

Thence southwesterly, crossing the said property, South 55°20'01" West, 13.40 feet to a point being 54.90 feet right of centerline of right of way of Georgesville Road station 124+60.03;

Thence southerly, crossing the said property, South 19°29'47" East, 30.76 feet to a point being 68.68 feet right of centerline of right of way of Georgesville Road station 124+32.52;

Thence southerly, crossing the said property, South 9°04'20" West, 19.81 feet to the said southerly existing right of way of the railroad subject property and being 68.00 feet right of centerline of right of way of Georgesville Road station 124+12.73;



The bearings on this plan are based on the Ohio State Plane Coordinate System, South Zone, NAD83 (2011). Said bearings originated from a field traverse which was referenced to the said coordinate system by GPS observations and observations of selected stations in the Ohio Department of Transportation Virtual Reference Station Network. The portion of the centerline of Georgesville Road having a bearing of North 7°06'40" East, is designated the "Basis of Bearing" for this description.

All stations and offsets are referenced to the centerline of existing right of way as found on plans named "Sullivant/Georgesville Camp Chase Trail Connector" as filed with the City of Columbus and designated as "3194-E".
