LEGAL DESCRIPTION OF A 20' TEMPORARY CONSTRUCTION EASEMENT

Hymer and Marian L. Hymer, as recorded in Official Record 13912, Page B13 and Official Record 10592, Page H16, on the northerly line of Virginia Military Survey No. 5242, the southerly line of Virginia Military Survey No. 5243; thence, along the grantor's northerly property line and the southerly property line of a tract in the name of Blauser Capital Ltd., an Ohio Limited Liability Company, as recorded in Instrument Number 200309240305299, South 81 degrees 05 minutes 33 seconds West, a distance of 1566.05 feet to the **Point of Beginning** of the easement herein described;

Thence, leaving said property line, through the grantor's tract, the following nine (9) courses:

- 1. South 41 degrees 18 minutes 15 seconds East, a distance of 71.06 feet to a point;
- 2. North 81 degrees 05 minutes 33 seconds East, a distance of 1728.23 feet to a point;
- 3. South 54 degrees 21 minutes 19 seconds East, a distance of 23.69 feet to a point;
- 4. South 13 degrees 08 minutes 41 seconds West, a distance of 318.90 feet to a point;
- 5. North 76 degrees 51 minutes 19 seconds West, a distance of 20.00 feet to a point;
- 6. North 13 degrees 08 minutes 41 seconds East, a distance of 305.53 feet to a point;
- 7. North 54 degrees 21 minutes 19 seconds West, a distance of 2.13 feet to a point;
- 8. South 81 degrees 05 minutes 33 seconds West, a distance of 1731.04 feet to a point;
- 9. North 41 degrees 18 minutes 15 seconds West, a distance of 94.75 feet to a point on the grantor's northerly property line and the southerly property line of said Blauser tract;

Thence, along said property line, North 81 degrees 05 minutes 33 seconds East, a distance of 23.69 feet to the **Point of Beginning** and containing 0.9817 acres, and being within Franklin County Auditor's Permanent Parcel Number 010-258726-00.
