## PARCEL 5-S1 ARTERIAL STREET REHABILITATION - POLARIS PARKWAY PERPETUAL EASEMENT TO CONSTRUCT AND MAINTAIN A SEWER IN THE NAME AND FOR THE USE OF THE CITY OF COLUMBUS, DELAWARE COUNTY, OHIO

A perpetual easement for the construction and maintenance of a sewer in, upon and over the within described real estate. Grantor/Owner herein retains the right to use said real estate for any and all other purposes provided that such use does not interfere with nor impair the exercise of the easement herein granted (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

## [Surveyor's description of the premises follows]

Situated in the City of Columbus, County of Delaware, and State of Ohio, being in Farm Lots 18 & 19, Quarter Township 4, Township 3 North, Range 18 West of the United States Military District, and being a part of that 1.477 acre tract conveyed to N.P. Limited Partnership, an Ohio Limited Liability Partnership, by Deed Volume 604, Page 59, all references being to the Delaware County Recorder's Office, Delaware County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the east side of the centerline of existing right-of-way of Orion Place, as shown and delineated upon the centerline plat with the right-of-way plans designated as Arterial Street Rehabilitation – Polaris Parkway prepared for the City of Columbus, Department of Public Services, by Carpenter Marty Transportation Inc., as recorded in Official Record Volume 1450, Page 927 (made a part hereof by reference), and being more particularly described as follows:

Beginning, for reference, at a 1" iron pipe found with a yellow cap stamped "CIVIL ENGR ASSOC." at a point of tangency in the centerline of Polaris Parkway, said pin being Station 169+55.73 in said centerline;

Thence along said centerline with a curve to the right having a radius of 1,762.95 feet, a central angle of 18° 03' 40", an arc length of 555.73 feet, a chord bearing South 55° 12' 27" West, and a chord distance of 553.43 feet to the existing intersection of said line with the existing centerline of Orion Place, said point being Station 164+00.00 in said centerline of Polaris Parkway;

Thence along the centerline of said Orion Place the following two courses:

- 1) South 25° 45' 43" East a distance of 212.81 feet to a point of curvature, said point being Station 2+12.81 in said centerline;
- 2) With a curve to the right having a radius of 900.00 feet, a central angle of 4° 11' 47", an arc length of 65.92 feet, a chord bearing South 23° 39' 49" East, and a chord distance of 65.90 feet to Station 2+78.73 in said centerline;

Thence North 68° 26' 04" East a distance of 54.50 feet to a 1" iron pipe found in the existing easterly right-of-way line of said Orion Place, said pipe being 54.50 feet left of Station 2+78.73 in said centerline;

Thence along the Grantor's southerly line North 87° 04' 13" East a distance of 21.08 feet (passing an iron pin set at a distance of 11.07 feet) to the easterly line of an existing 20.00 foot utility easement, as recorded in Plat Book 24, Page 137, said point being 74.50 feet left of Station 2+84.95 in said centerline, said point also being the TRUE POINT OF BEGINNING of the parcel herein conveyed;

Thence across said 1.477 acre tract along said easterly line the following two courses:

1) With a curve to the left having a radius of 974.50 feet, a central angle of 4° 35' 33", an arc length of 78.11 feet, a chord bearing North 23° 27' 57" West, and a chord distance of 78.09 feet to a point 74.50 feet left of Station 2+12.81 in said centerline;

2) North 25° 45' 41" West a distance of 7.22 feet to the southerly corner of a 0.024 acre sewer easement granted to the City of Columbus by Official Record 537, Page 102, said point being 74.50 feet left of Station 2+05.59 in said centerline;

Thence along the easterly line of said 0.024 acre easement North 19° 32' 04" West a distance of 50.70 feet to a point 80.00 feet left of Station 1+55.19 in said centerline;

Thence along the proposed easterly sewer easement line the following two courses:

- 1) South 25° 45' 43" East a distance of 57.62 feet to a point 80.00 feet left of Station 2+12.81 in said centerline:
- 2) With a curve to the right having a radius of 980.00 feet, a central angle of 4° 41' 54", an arc length of 80.36 feet, a chord bearing South 23° 24' 46" East, and a chord distance of 80.34 feet to the Grantor's southerly line, said point being 80.00 feet left of Station 2+86.61 in said centerline;

Thence along said southerly line South 87° 04' 13" West a distance of 5.79 feet to the TRUE POINT OF BEGINNING, containing 0.014 acres, of which the present road occupies 0.000 acres.

The above described tract is located in Auditor's Parcel Number 318-443-02-008-004.

The bearings found herein are based on the Ohio State Plane Coordinate System, North Zone, NAD 83 (2011). Bearings shown heron are based on true north observed by Carpenter Marty Transportation, using a Leica GNSS Viva CS15/GS15 receiver. Based on this the bearing of Interstate 71 is North 3° 32' 22" East.

Monuments referred to as iron pins set are <sup>3</sup>/<sub>4</sub>" x 30" topped by a 2" diameter aluminum cap stamped "CITY OF COLUMBUS R/W, P.S. 8124". Right of way monuments called for as set herein shall be set upon completion of the acquisition process.
