Grantor/Owner, for himself and his heirs, executors, administrators, successors and assigns, reserves all existing rights of ingress and egress to and from any residual area (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

Situated in the City of Columbus, County of Delaware, and State of Ohio, being in Farm Lot 19, Quarter Township 4, Township 3 North, Range 18 West of the United States Military District, and being a part of that 1.133 acre tract conveyed to NP Skyline, LLC, an Ohio Limited Liability Company, by Official Record 526, Page 1337, all references being to the Delaware County Recorder's Office, Delaware County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the east side of the centerline of existing right-of-way of Orion Place, as shown and delineated upon the centerline plat with the right-of-way plans designated as Arterial Street Rehabilitation - Polaris Parkway prepared for the City of Columbus, Department of Public Services, by Carpenter Marty Transportation Inc., as recorded in Official Record Volume 1450, Page 927 (made a part hereof by reference), and being more particularly described as follows:

Beginning, for reference, at a 1 " iron pipe found with a yellow cap stamped "CIVIL ENGR ASSOC." at a point of tangency in the centerline of Polaris Parkway, said pin being Station $169+55.73$ in said centerline;

Thence along said centerline with a curve to the right having a radius of $1,762.95$ feet, a central angle of $18^{\circ} 03^{\prime} 40^{\prime \prime}$, an arc length of 555.73 feet, a chord bearing South $55^{\circ} 12^{\prime} 27^{\prime \prime}$ West, and a chord distance of 553.43 feet to the existing intersection of said line with the existing centerline of Orion Place, said point being Station 164+00.00 in said centerline of Polaris Parkway;

Thence along the centerline of said Orion Place the following two courses:

1) South $25^{\circ} 45^{\prime} 43^{\prime \prime}$ East a distance of 212.81 feet to a point of curvature, said point being Station $2+12.81$ in said centerline;
2) With a curve to the right having a radius of 900.00 feet, a central angle of $4^{\circ} 11^{\prime} 47^{\prime \prime}$, an arc length of 65.92 feet, a chord bearing South $23^{\circ} 39^{\prime} 49^{\prime \prime}$ East, and a chord distance of 65.90 feet to Station $2+78.73$ in said centerline;

Thence North $68^{\circ} 26^{\prime} 04^{\prime \prime}$ East a distance of 54.50 feet to a $1^{\prime \prime}$ iron pipe found at the Grantor's northwesterly corner, said pipe being in the existing easterly right-of-way line of said Orion Place, said pipe being 54.50 feet left of Station $2+78.73$ in said centerline, said pipe also being the TRUE POINT OF BEGINNING of the parcel herein conveyed;

Thence along the Grantor's northerly line North $87^{\circ} 04^{\prime} 13^{\prime \prime}$ East a distance of 11.07 feet to an iron pin set on the proposed easterly right-of-way line of said Orion Place, said pin being 65.00 feet left of Station $2+82.03$ in said centerline;

Thence along said easterly line the following two courses:

1) With a curve to the right having a radius of 965.00 feet, a central angle of $13^{\circ} 45^{\prime} 29^{\prime \prime}$, an arc length of 231.72 feet, a chord bearing South $14^{\circ} 28^{\prime} 35^{\prime \prime}$ East, and a chord distance of 231.16 feet to a magnetic nail set 65.00 feet left of Station $4+98.14$ in said centerline;

2) South $7^{\circ} 35^{\prime} 35^{\prime \prime}$ East a distance of 51.15 feet to an iron pin set in the Grantor's southerly line, said pin being 65.00 feet left of Station 5+49.29 in said centerline;

Thence along said southerly line South $84^{\circ} 40^{\prime} 29^{\prime \prime}$ West a distance of 12.52 feet to an iron pin found with a yellow cap stamped "WOOLPERT" at the Grantor's southwesterly corner, said pin being 52.49 feet left of Station $5+48.79$ in said centerline;

Thence along the Grantor's westerly line, also being the existing easterly right-of-way line of said Orion Place, the following two courses:

1) North $5^{\circ} 19^{\prime} 16^{\prime \prime}$ West a distance of 50.70 feet to a point 54.50 feet left of Station $4+98.14$ in said centerline;
2) With a curve to the left having a radius of 954.50 feet, a central angle of $13^{\circ} 58^{\prime} 06^{\prime \prime}$, an arc length of 232.70 feet, a chord bearing North $14^{\circ} 34^{\prime} 53^{\prime \prime}$ West, and a chord distance of 232.12 feet to the TRUE POINT OF BEGINNING, containing 0.069 acres, of which the present road occupies 0.000 acres.

Transportation, using a Leica GNSS Viva CS15/GS15 receiver. Based on this the bearing of Interstate 71 is North $3^{\circ} 32^{\prime} 22^{\prime \prime}$ East.

Monuments referred to as iron pins set are $3 / 4$ " x 30 " topped by a 2 " diameter aluminum cap stamped "CITY OF COLUMBUS R/W, P.S. 8124". Right of way monuments called for as set herein shall be set upon completion of the acquisition process.
