Situated in the City of Columbus, County of Delaware, and State of Ohio, being in Farm Lot 19, Quarter Township 4, Township 3 North, Range 18 West of the United States Military District, and being a part of that 1.189 acre tract conveyed to McDonalds Corporation, a Delaware Corporation, by Deed Volume 627, Page 327, all references being to the Delaware County Recorder's Office, Delaware County, Ohio, and being bounded and more particularly described as follows:

Being a parcel of land lying on the west side of the centerline of existing right-of-way of Orion Place, as shown and delineated upon the centerline plat with the right-of-way plans designated as Arterial Street Rehabilitation – Polaris Parkway prepared for the City of Columbus, Department of Public Services, by Carpenter Marty Transportation Inc., as recorded in Official Record Volume 1450, Page 927 (made a part hereof by reference), and being more particularly described as follows:

Beginning, for reference, at a 1" iron pipe found with a yellow cap stamped "CIVIL ENGR ASSOC." at a point of tangency in the centerline of Polaris Parkway, said pin being Station 169+55.73 in said centerline;

Thence along said centerline with a curve to the right having a radius of 1,762.95 feet, a central angle of 18° 03' 40", an arc length of 555.73 feet, a chord bearing South 55° 12' 27" West, and a

chord distance of 553.43 feet to the existing intersection of said line with the existing centerline of Orion Place, said point being Station 164+00.00 in said centerline of Polaris Parkway;

Thence along the centerline of said Orion Place the following two courses:

- 1) South 25° 45' 43" East a distance of 212.81 feet to a point of curvature, said point being Station 2+12.81 in said centerline;
- 2) With a curve to the right having a radius of 900.00 feet, a central angle of 9° 29' 36", an arc length of 149.12 feet, a chord bearing South 21° 00' 55" East, and a chord distance of 148.95 feet to Station 3+61.93 in said centerline;

Thence South 73° 43' 55" West a distance of 54.43 feet to an iron pin found at the Grantor's northeasterly corner, said pin being in the existing westerly right-of-way line of said Orion Place, said pin being 54.50 feet right of Station 3+61.93 in said centerline, said pin also being the TRUE POINT OF BEGINNING of the parcel herein conveyed;

Thence along the Grantor's easterly line, also being said existing westerly right-of-way line of said Orion Place, the following two courses:

- 1) With a curve to the right having a radius of 845.50 feet, a central angle of 8° 40' 17", an arc length of 127.96 feet, a chord bearing South 11° 55' 59" East, and a chord distance of 127.84 feet to a point 54.50 feet right of Station 4+98.14 in said centerline;
- 2) South 9° 51' 54" East a distance of 36.82 feet to the Grantor's southeasterly corner, said point being 53.04 feet right of Station 5+34.93 in said centerline;

Thence along the Grantor's southerly line South 71° 18' 03" West a distance of 7.09 feet to a point 60.00 feet right of Station 5+36.30 in said centerline;

Thence across said 1.189 acre tract along the proposed temporary westerly right-of-way line of said Orion Place the following four courses:

- 1) North 8° 25' 26" West a distance of 83.07 feet to a point 60.00 feet right of Station 4+50.00 in said centerline;
- 2) North 80° 57' 57" West a distance of 26.85 feet to a point 85.23 feet right of Station 4+40.00 in said centerline;
- 3) North 12° 24' 46" West a distance of 40.75 feet to a point 85.00 feet right of Station 3+95.00 in said centerline;
- 4) North 10° 11' 13" East a distance of 32.66 feet to the Grantor's northerly line, said point being 71.00 feet right of Station 3+62.69 in said centerline;

Thence along said northerly line North 71° 18' 03" East a distance of 16.52 feet to the TRUE POINT OF BEGINNING, containing 0.061 acres, of which the present road occupies 0.000 acres.
