The Broad Meadows Underground Street Lighting Improvements project will install (13) 100 Watt 480 volt LED decorative post top light poles in the Broad Meadows area of Columbus.

The planning area for this project is "Far North" and includes Highfield Drive and Milton Avenue, south of Broad Meadows Boulevard.

6. <u>A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.</u>

Following the legislation and execution of the construction contract, the work is slated to be completed within 180 days. Allowing 3 months for the legislation and execution process, estimated construction would begin in June of 2017, and be completed by December 2017.

This work is being performed with the City of Columbus's goal to light every street. The addition of street lighting within the Broad Meadows area could provide both a sense of

The bid amount and proposed award amount is \$86,112.40, including a 10% construction contingency amount that will be utilized to fund needed and approved changes in the work.
