Work consists of construction of approximately 3,100 linear feet of storm sewer and 3,100 linear feet of water line, sidewalks, and extended detention swales, and other such work as may be necessary to complete the contract, in accordance with the drawings (CC16914/14-143).

Project is located in Near South planning area.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

The work under this contract shall be completed in a manner acceptable to the City within 365 calendar days after the date of the Notice to Proceed.

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

The project was initiated due to public complaints of poor drainage along Smith Road and the requests by the community for sidewalks.

8. **An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.**

The bid amount and proposed award amount is **\$1,787,235.33**, including a **20%** construction contingency amount that will be utilized to fund needed and approved changes in the work.

No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
