**EXPLANATION OF LEGISLATION**

**Background:**

This ordinance will grant permission to the following group to apply for temporary liquor permits authorizing the sale and sampling of wine at a special event to be held during 2017:

- 1) SID Public Services Association for the Pearl Market, Tuesdays and Fridays, June 2 – October 20.

This organization wishes to sell and provide wine sampling to eligible patrons on city streets and city property to be used for the event. This is the first year for closing a public street to hold the event to conduct wine sampling and sales. In 2016 the Ohio General Assembly passed a law that allows Ohio wineries without a distributor to direct market/sell at farmers markets.

The City of Columbus, acting by and through its Director of Recreation and Parks, is required to grant approval to the organizer of this event so they may obtain the required permits from the Ohio Department of Commerce, Division of Liquor Control.

**WHEREAS**, the following special event will take place during 2017: Pearl Market, and

**WHEREAS**, following precedent, the organizer of this event wishes to sell and provide sampling of wine at said event; and

**WHEREAS**, to this end, permission from the City of Columbus is required as it is the property owner involved; now, therefore

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:**

**SECTION 1.** That the Director of Recreation and Parks be and is hereby authorized and directed to grant consent on behalf of the City of Columbus to the following organization to apply for appropriate liquor permits to enable the non-profit group to sell and provide sampling of wine during the hours specified in said permits and at a specified locations during their 2017 special event:

- 1) SID Public Services Association for the Pearl Market, Tuesdays and Fridays, June 2 – October 20..

**SECTION 2.** That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
