Thence South 85 degrees 39 minutes 58 seconds East, along the north line of said Lot 2 and along the south line of said Lot 1, a distance of 6.50 feet to a point, said point being 46.46 feet right of James Road proposed centerline of construction Station 115+19.74;

Thence South 04 degrees 30 minutes 02 seconds West, across said Lot 2, a distance of 54.18 feet to a point on the south line of said Lot 2, being on the north line of said Lot 3, said point being 46.42 feet right of James Road proposed centerline of construction Station 114+65.56;

Thence **North 85 degrees 39 minutes 58 seconds West**, along the south line of said Lot 2 and along the north line of said Lot 3, a distance of **6.50 feet** to the **POINT OF BEGINNING** for this description.

The above described temporary easement contains a total area of **0.008 acres** located within Franklin County Auditor's parcel number 010-095779.
