Sir,

The following investigation was conducted concerning the City of Columbus' 2017 annual objection to the renewal of liquor permit 4103160 issued to I LOVE THIS BAR LLC, which is doing business as PARK ST. CANTINA located at 491 PARK ST. COLUMBUS, OHIO 43211. The recorded owner of said permit is FADI MICHAEL.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **D5**, and **D6** permit by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violations between **September 10, 2016** and **November of 2017**:

A review of the Columbus Division of Police records revealed the Division of Police have created the following listed **(98)** ninety eight official police reports concerning incidents at the listed liquor establishment between January 2016 and November 2017. These reports referenced felonious assaults, simple assaults, disorderly conduct, rapes, felony thefts, misdemeanor thefts, breaking and entering, fraud, criminal damaging, missing persons, vandalism, property damage, burglary, menacing, wanted persons, and liquor law offenses.

In addition, the Columbus Division of Police has been dispatched to **491 Park St.** Columbus, Ohio 43215 on **(76) seventy six** separate occasions between the same time period at **Park St. Cantina**.

As a result of a long term investigation conducted by the Ohio Investigative Unit a total of (48) forty eight criminal charges for Underage Possession Alcoholic Beverage and/or Furnishing Alcohol to Underage Person were issued between July 2, 2016 and August 11, 2017.
