thence South 04 Degrees 20 Minutes 54 Seconds West, with said westerly existing rightof-way line, westerly line of said 0.928 acre tract, and easterly line of said 4.385 acre tract, a distance of 14.14 feet, to the intersection of said westerly existing right-of-way line, said westerly line, and easterly line of said 4.385 acre tract with the northerly line of Canterbury Service Road (Ordinance Number 1547-90) and a northerly line of said 0.928 acre tract, located 40.00 feet left of existing centerline of right-of-way station 200+18.54 for Ohiohealth Parkway and 18.86 feet left of centerline of right-of-way and construction station 106+54.54 for East-West Road;

North 86 Degrees 19 Minutes 16 Seconds West, a distance of 390.60 feet, to a point, located 20.03 feet left of centerline of right-of-way and construction station 102+10.43 for East-West Road;

South 74 Degrees 37 Minutes 52 Seconds West, a distance of 121.03 feet, to a 1 inch iron pipe found at a southwesterly corner of said 4.385 acre tract, a northwesterly corner of said 0.928 acre tract, a northeasterly corner of the remainder of the 1.109 acre tract conveyed to the State of Ohio as Parcel 139 WD by deed of record in Deed Book 3653, Page 465, and a southeasterly corner of said 1.614 acre tract, being the intersection of said northerly right-of-way line with said
