## **DESCRIPTION OF 0.011 ACRES**

## Temporary Easement Christopher Moses 987 S Broadleigh Rd

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Section 18, Township 12, Range 21, Refugee Lands and being part of Lot 38 as the same is numbered and delineated upon the recorded plat East Minster in Plat Book 16, Page 15 and described in a deed to Christopher Moses by deed of records in Instrument Number 200510040208481. Commencing at an iron pin found in the northeast corner of Lot 37 as the same is numbered and delineated upon the recorded plat East Minster in Plat Book 16, Page 15, and described in a deed to Cecilia Ann Knadler Watson by deed of records in Official Record Book 28324C10, same being the southeast corner of the said grantor's Lot 38 and lying in the existing westerly right of way line of S Broadleigh Road (50' width) and also being on a curve.

Thence **N 58 degrees 16 minutes 00 seconds W** a distance of **10.06 feet** with the property line between said Lot 37 and said Lot 38 to a point in said line, said point being 10.00 feet westerly of as measured by right angles from the existing westerly right of way line of S Broadleigh Road and the *TRUE POINT OF BEGINNING*;

Thence continuing **N** 58 degrees 16 minutes 00 seconds **W** a distance of 10.06 feet with the property line between said Lot 37 and said Lot 38 to a point in said line, said point being the beginning of a curve;

Thence across the grantor's said Lot 38 with a curve to the left and being 20.00 feet westerly of as measured by right angles from the existing westerly right of way line of S Broadleigh Road and having as its elements a delta of 12°26'09", a radius of 214.81 feet, an arc length of 46.62 feet with a **Chord Bearing of N31°57'48' E and a Chord length of 46.53 feet** to a point in the south line of said Thomas and McCoy's Lot 39, same being the northerly line of the grantor's Lot 38:

Thence S 66 degrees 47 minutes 38 seconds E a distance of 10.01 feet with the property line between said Lot 39 and said Lot 38 to a point, said point being the beginning of a curve;

Thence across said grantor's Lot 38 with a curve to the right, having as its elements a delta of 12°15'39", a radius of 224.81 feet, an arc length of 48.11 feet with a **Chord Bearing of S31°45'46'** W and a **Chord length of 48.02 feet** to the *TRUE POINT OF BEGINNING*; containing 0.011 acre of land more or less.

The above described area contains a total of **0.011 acres** within Franklin County Auditor's Parcel Number 010-090261-00, which includes 0.000 acres in the present road occupied.
