Thence along the said southerly proposed right-of-way of Morse Road, South 86°34'28" East, a distance of 238.09 feet to an iron pin set on the said right-of-way line on the eastern property line of said parcel, being 50.00 feet right of Morse Road centerline Station 255+76.96;

The above described area is within Auditors Permanent Parcel Numbers 025-011229 (0.060 acres) and 025-011224 (0.014 acres).


