Being a parcel of land lying on the left side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning on the westerly existing right-of-way of Hamilton Road, said point being 60.00 feet left of centerline Station 95+50.63;

Thence along the southerly property line of said 19.114 acre tract and with a curve to the left having a radius of 49.00 feet, a central angle of 11°50'38", an arc length of 10.13 feet, and a chord that bears North 78°01'42" West a distance of 10.11 feet to a point on the property line of the said 19.114 acre tract, being 70.00 feet left of centerline Station 90+52.13;

Thence across the said 19.114 acre tract, North 3°28'21" East a distance of 32.40 feet to a point on the northerly property line of said 19.114 acre tract, being 70.00 feet left of centerline Station 90+84.53;

Thence along the northerly property line of said 19.114 acre tract and with a curve to the left having a radius of 49.00 feet, a central angle of 12°10'24", an arc length of 10.41 feet, and a chord that bears North 77°42'01" East a distance of 10.39 feet to a point on the existing western right-of-way line of Hamilton Road, being 60.00 feet left of centerline Station 90+87.36;

Thence along the existing westerly right-of-way line of Hamilton Road, South 3°28'21" West a distance of 36.73 feet to the point of beginning, containing 0.008 acres, more or less.


