5. A description of work performed to date as part of the contract and a full description of work to be performed during any future phasing of the contract.

This project consists of two design phases. The first phase completed a study of two stations, Bethel and Henderson, and evaluated alternatives that would best utilize the stations and improve system efficiencies. During the first phase the consultant coordinated with the consultant that was completing the Comprehensive and Water Distribution Master Plan project and the Water Distribution Staff. The phase one study generated recommendations that were evaluated during the Business Case Evaluation (BCE) process. The BCE ultimately approved the recommendations to the Bethel Road Booster Station and to the Henderson Road Booster Station.

Phase two (Modification No. 1) included implementing the recommendations of the BCE process. The consultant was responsible for the design and plan preparation of the project, bidding, review of construction submittals during construction, and preparation of record plans. The design consisted of splitting the Bethel Road Booster Station to enable better utilization of the station. The consultant was responsible for preparing the bidding documents and answering any questions during the bidding of the project. During construction the consultant reviewed all submittals and assisted in responding to questions.
