Murrell, of record in Instrument Number 199906150152432, said point being 30.00 feet right of James Road proposed centerline of construction Station 138+80.28;

Thence South 87 degrees 53 minutes 44 seconds East, along the north line of the grantor's land and along the south line of said Murrell tract, a distance of 3.00 feet to a point, said point being 33.00 feet right of James Road proposed centerline of construction Station 138+80.38;

Thence North 04 degrees 02 degrees 28 minutes East, along the existing east right-of-way line for said James Road and along the west line of the grantor's land, a distance of 20.25 feet (passing at a distance of 10.25 feet the northwest corner of said Lot 21, being the southwest corner of said Lot 20) to the **POINT OF BEGINNING** for this description.
