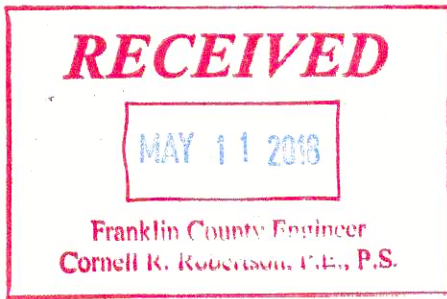

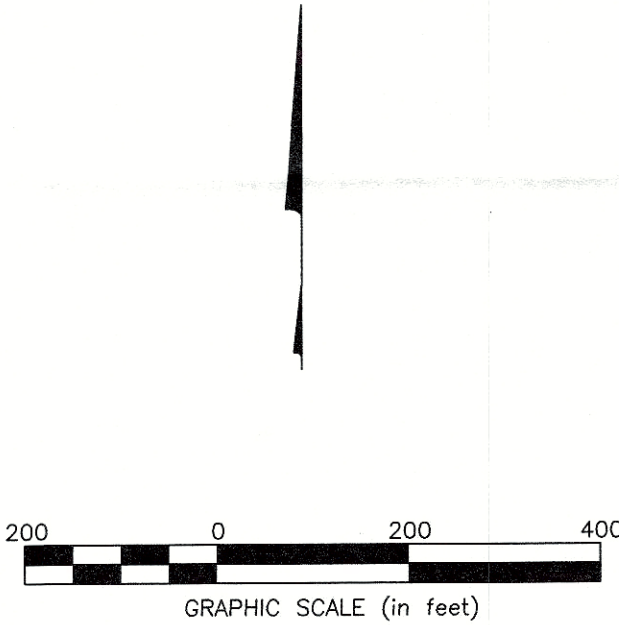
PROPOSED CORPORATION LINE
