The contract will continue to provide power line clearance, tree trimming and removal services around the Distribution and Street Lighting System, as well as tree trimming removal services required by the Department of Public Utilities for areas in and around the City, and other such work as may be necessary.

If the contract modification was not anticipated and explained in the original contract legislation a full explanation as to the reasons the work could not have been anticipated is required. Anticipated modification. The original contract allows for three (3) extension periods on a year to year basis. The Division of Power did not have all of the necessary funding established at the beginning of 2018 with modification No. 2. This anticipated modification No. 3 is to provide the additional funding necessary for the payment of services to be provided through April 10, 2019.

The vendor recently changed their status from a Company to a LLC, but the EIN number did not change. The ordinance for this modification No. 3 will also authorize the assignment of all past, present and future business done by the City of Columbus with Asplundh Tree Expert Company, EIN #23-1277550 to be assigned to Asplundh Tree Expert, LLC, EIN #23-1277550.

An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation)

The same exact service is required as originally detailed in the contract documents. No lower pricing/more attractive terms and conditions are anticipated at this time.

This contract will be funded incrementally with modifications on approximately an annual basis. Five contract modifications are anticipated at this time.
