Thence South 86° 12' 32" East, following the northerly line of said 28.362 acre tract and the southerly line of said Lot 1, for a distance of 96.21 feet to a corner of said 28.362 acre tract and the northwesterly corner of a 2.647 acre tract as described in a deed to Kensington Place, Inc. in O.R. 18503 C-14;

Thence South 03° 52' 14" West, following the westerly line of said 2.647 acre tract, for a distance of 2.06 feet to the **True Place of Beginning** of the parcel herein described;

Thence South 03° 52' 14" West, continuing along the westerly line of said 2.647 acre tract, for a distance of 157.73 feet to a point;

Thence passing through said 28.362 acre tract for the following eight (8) courses and distances;

1. South 55° 43' 14" West, for a distance of 46.74 feet to a point;

2. Along the arc of a curve to the right, having a radius of 200.00 feet, a delta of  $16^{\circ}$  53' 36", a chord bearing of South  $42^{\circ}$  43' 03" West, a chord distance of 58.76 feet, for an arc length of 58.97 feet to a point;

3. South 51° 09' 51" West, for a distance of 67.24 feet to a point;

4. Along the arc of a curve to the right, having a radius of 110.00 feet, a delta of 50° 15' 16", a chord bearing of South 76° 17' 29" West, a chord distance of 93.42 feet, for an arc length of 96.48 feet to a point;

5. South 05° 39' 04" West, for a distance of 17.30 feet to a point;

6. North 84° 20' 22" West, for a distance of 10.00 feet to a point;

7. North 05° 39' 04" East, for a distance of 18.78 feet to a point;

8. Along the arc of a curve to the right, having a radius of 110.00 feet, a delta of 32° 42' 52", a chord bearing of North 56° 57' 26" West, a chord distance of 61.96 feet, for an arc length of 62.81 feet to the easterly right of way of I-Rt. 670 and the westerly line of said 28.362 acre tract;

Thence North 21° 32' 26" East, following the westerly right of way of I-Rt. 670, for a distance of 23.37 feet to a point;

Thence passing through said 28.362 acre tract for the following nine (9) courses and distances;

1. Along the arc of a curve to the left, having a radius of 90.00 feet, a delta of  $37^{\circ}$  11' 29", a chord bearing of South  $52^{\circ}$  13' 28" East, a chord distance of 57.40 feet, for an arc length of 58.42 feet to a point;

2. North 05° 39' 04" East, for a distance of 8.96 feet to a point;

- 3. South 84° 20' 22" East, for a distance of 10.00 feet to a point;
- 4. South 05° 39' 04" West, for a distance of 10.77 feet to a point;

5. Along the arc of a curve to the left, having a radius of 90.00 feet, a delta of  $51^{\circ}$  32' 31", a chord bearing of North 76° 56' 07" East, a chord distance of 78.26 feet, for an arc length of 80.96 feet to a point;

6. North 51° 09' 51" East, for a distance of 67.24 feet to a point;

7. Along the arc of a curve to the left, having a radius of 180.00 feet, a delta of  $53^{\circ} 22' 41''$ , a chord bearing of North  $24^{\circ} 28' 31''$  East, a chord distance of 161.69 feet, for an arc length of 167.69 feet to a point;

8. North 02° 12' 50" West, for a distance of 25.74 feet to a point;

9. Along the arc of a curve to the right, having a radius of 37.00 feet, a delta of 90° 11' 50", a chord bearing of North 42° 53' 05" East, a chord distance of 52.42 feet, for an arc length of 58.25 feet to the **True Place of Beginning**, and containing 11,696 square feet or 0.269 acres of land, more or less, in Franklin County Auditor Parcel Number 010-126709, of which Present Road Occupied is 0.0000 acres of land.
