[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, located in the Quarter Township 3, Township 1, Range 17 of the United States Military District and within a 28.362 acre tract as described in a deed to Falcon Four Property Holdings in Instrument Number 201310310183576 (All records are on file at the Recorder's Office, Franklin County, Ohio) and being more fully described as follows:

Commencing at a 1 inch iron pipe found at the southeasterly corner of Lot 1 of the Kensington Subdivision as shown on Plat 10 page 34, located at the terminus of Parkview Boulevard's westerly right of way and also being a common corner of said 28.362 acre tract;

Thence South 85° 56' 42" East, following the northerly line of said 28.362 acre tract and the terminus of Parkview Boulevard, for a distance of 49.99 feet to the **True Place of Beginning** of the parcel herein described;

Thence South 85° 56' 42" East, continuing along the northerly line of said 28.362 acre tract and the terminus of Parkview Boulevard, for a distance of 5.01 feet to a point;

Thence passing through said 28.362 acre tract for the following twenty two (22) courses and distances;

1. South 00° 58' 32" West, for a distance of 56.83 feet to a point;
2. South 15° 44' 33" East, for a distance of 32.20 feet to a point;
3. South 34° 40' 26" East, for a distance of 55.49 feet to a point;
4. South 48° 45' 34" East, for a distance of 38.11 feet to a point;
5. South 86° 05' 29" East, for a distance of 33.62 feet to a point;

17. Along the arc of a curve to the left, having a radius of 210.00 feet, a delta of $13^{\circ} 05' 47''$, a chord bearing of North $82^{\circ} 41' 48''$ West, a chord distance of 47.90 feet, for an arc length of 48.00 feet to a point;

21. Along the arc of a curve to the right, having a radius of 137.00 feet, a delta of $77^{\circ} 07' 22''$, a chord bearing of North $37^{\circ} 35' 13''$ West, a chord distance of 170.80 feet, for an arc length of 184.41 feet to a point;

22. North $00^{\circ} 58' 28''$ East, for a distance of 38.01 feet to the **True Place of Beginning**, and containing 5,720 square feet or 0.131 acres of land, more or less, in Franklin County Auditor Parcel Number 010-126709, of which Present Road Occupied is 0.0000 acres of land.

The bearings for this description are based on Ohio State Plane, South Zone and referenced to the North American Datum of 1983 (2011) determined by GPS Observations between Franklin County Control Monuments "COC 48-82" and "COC 37-82" as being North $83^{\circ} 48' 51''$ West.
