Sir,

The following investigation was conducted concerning the City of Columbus' 2018 annual objection to the renewal of liquor permit **4786605** issued to **KOOKIE INCORPORATED LLC**, which is doing business as **Kookies Bar** located at **1662 W Mound St. COLUMBUS, OHIO 43223**. The recorded owner of said permit is **Lourdie Phillipe**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **D1, D3 and D3A** permit by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violations between **2017** and **2018**:

A review of the Columbus Division of Police records revealed the Division of Police have created the following **(9) nine** listed official police reports concerning incidents at the listed liquor establishment between January 2017 and November 2018. These reports referenced felonious assaults, simple assault, drug offenses, robbery, breaking and entering, wanted persons and overdose.

In addition, the Columbus Division of Police have been dispatched to **1662 W Mound St.** Columbus, Ohio 43223 on **(35) thirty five** calls for service **(27) twenty seven** in 2017 and **(8) eight** in 2018 at **Kookies Bar.**

As a result of a long term investigation conducted over several months by the Columbus Division of Police Vice Unit there were a total of **(3)** **three** narcotics buys made inside the listed liquor establishment. The investigation however came to a sudden halt due to the establishment closing down abruptly.
