SUBJECT: Funding of Special Events – Hotel/Motel Tax

DATE: November 1, 2018

CRPD appreciates the past support from the Hotel/Motel Fund and requests the following funding to enhance cultural opportunities within the City for 2019. The following recommendation includes funding for events and programs that have a direct correlation on hotel/motel tax collections. We intend to allocate funding as follows:

Program Descriptions

City-wide music licensing – All public performances of music, whether live, recorded or broadcast, must be licensed. Three organizations (ASCAP, BMI and SESAC) license performance rights for most of the music copyright holders in the U.S. The city holds a “Local Government Entities” (Municipal) license with these three licensing agencies. The Municipal license covers facilities owned and/or operated by the city and any site engaged by the city for use by the city. The license covers any activities conducted, sponsored or presented by or under the auspices of the city including but not limited to concerts, parades, festivals, athletic events, dances or other social events. In addition to Recreation and Parks’ programs and facilities, coverage is extended to: Martin Luther King Jr. Celebration, Heritage Jazz Series, Columbus Commons Productions, Veterans’ Day Parade, King Arts Complex, Lincoln Theatre, Franklin Park Conservatory, Columbus Zoo and Aquarium, and all other city conducted programs and facilities that play or present music.

Sports Tournament Support- Lou Berliner Park is recognized nationally as a premiere mid-western athletic tournament facility. Sixty-five local, regional and national tournaments are held at Berliner Park annually. Over 130,000 participants competed in 2018 tournaments generating an economic impact over \$66 million for the local economy. In addition to competitors, Berliner Park recorded over 1 million park visitations in 2018. Designation of funding to support Berliner Park operations will assure that it remains a vital community asset.

Jazz & Rib Fest 40th Anniversary– A Columbus favorite and one of the region’s largest free jazz festivals, the festival features local, regional and international jazz artists performing a variety of genres and 22 national rib teams that compete for best ribs honors as chosen by BBQ critics and the public. 2019 marks the 40th Anniversary of the festival in downtown Columbus.

Special Fund – The Partnership Through Sponsorship Program (1995-2016) was the foundation for providing financial support to community events. In 2017, the program was expanded to allow neighborhood, city-wide and regional events to apply for funding through a rebranded program known as the Special Event Support Program. Awards are determined by a number of criteria including: event budget, public participation, event duration, and geographic location.

Planning for these events is underway, and many of the community organizations are anxious to know if there will be an opportunity to receive funds in 2019. Please let us know if you have any questions or require additional information.
