Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Section 6 in original Madison Township, Township 11, Range 21 of the Congress Lands. The herein described parcel lies on the right side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "SPEEDWAY SUPERAMERICA LLC, A DELAWARE LIMITED LIABILITY COMPANY" (hereafter referred to as Grantor) as described in Instrument No. 199807160177992 of the Franklin County Recorder's Office and being more particularly described as follows:

COMMENCING at 43.00 feet right of the existing centerline of right-of-way of Refugee Road at station 11+64.99 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

THENCE South 85 deg. 43 min. 08 sec. East for a distance of **193.86 feet** to 43.00 feet right of the existing centerline of right-of-way of Refugee Road at station 13+58.85;

THENCE South 04 deg. 16 min. 52 sec. West for a distance of **11.31 feet** to 54.31 feet right of the existing centerline of right-of-way of Refugee Road at station 13+58.85;

THENCE North 85 deg. 44 min. 08 sec. West for a distance of **193.86 feet** to 54.37 feet right of the existing centerline of right-of-way of Refugee Road at station 11+64.99;

THENCE North 04 deg. 16 min. 52 sec. East for a distance of 11.37 feet BACK TO THE TRUE POINT OF BEGINNING.

The above-described parcel contains 0.050 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 530-148885.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.
