## PARCEL 48-T1 FRA-CR 14-1.99 TEMPORARY EASEMENT FOR THE PURPOSE OF PERFORMING THE WORK NECESSARY TO COMPLETE GRADING FOR 24 MONTHS FROM DATE OF ENTRY BY THE CITY OF COLUMBUS, FRANKLIN COUNTY, OHIO

[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 50 in original Truro Township, Township 12, Range 21 of the Refugee Lands, and being part of Reserve "A" as described in the East Landings Section 1, Part 1 as recorded in Plat Book 110, page 4 of the Franklin County Recorder's Office. The herein described parcel lies on the left side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "THE EAST LANDINGS HOMEOWNERS' ASSOCIATION, INC., AN OHIO NON PROFIT CORPORATION" (hereafter referred to as Grantor) as described in Instrument No. 200811250170174 also of the Franklin County Recorder's Office and being more particularly described as follows:

**COMMENCING** at 75.00 feet left of the existing centerline of right-of-way of Refugee Road at station 84+21.88 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

THENCE on a tangent curve to the right, with an ARC LENGTH of 13.86 feet, a RADIUS of 20.00 feet, a TANGENT LENGTH of 7.22 feet, a DELTA ANGLE of 39 deg. 41 min. 49 sec., with a CHORD BEARING of North 65 deg. 50 min. 05 sec. West and a CHORD DISTANCE of 13.58 feet to 79.61 feet left of the existing centerline of right-of-way of Refugee Road at station 84+09.10;

**THENCE South 81 deg. 18 min. 52 sec. East** for a distance of **60.54 feet** to 75.00 feet left of the existing centerline of right-of-way of Refugee Road at station 84+69.46;

THENCE North 85 deg. 40 min. 59 sec. West for a distance of 47.58 feet BACK TO THE TRUE POINT OF BEGINNING.

The above-described parcel contains 0.003 acres total, including acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-282659.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.
