## PARCEL 52-T1 FRA-CR 14-1.99 TEMPORARY EASEMENT FOR THE PURPOSE OF PERFORMING THE WORK NECESSARY TO COMPLETE GRADING FOR 24 MONTHS FROM DATE OF ENTRY BY THE CITY OF COLUMBUS, FRANKLIN COUNTY, OHIO

[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 50 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "SEARS, ROEBUCK AND CO., A NEW YORK CORPORATION" (hereafter referred to as Grantor) as described in Deed Book 2485, page 481 of the Franklin County Recorder's Office and being more particularly described as follows:

**COMMENCING** at the at 87.06 feet left of the existing centerline of Right-of-way of Refugee Road at station 89+03.85 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

**THENCE North 04 deg. 23 min. 16 sec. East** for a distance of **23.95 feet** to 111.00 feet left of the existing centerline of right-of-way of Refugee Road at station 89+03.88;

**THENCE South 84 deg. 58 min. 26 sec. East** for a distance of **69.65 feet** to 110.14 feet left of the existing centerline of right-of-way of Refugee Road at station 89+73.53;

**THENCE South 03 deg. 30 min. 53 sec. West** for a distance of **22.82 feet** to 87.32 feet left of the existing centerline of right-of-way of Refugee Road at station 89+73.85;

**THENCE South 83 deg. 46 min. 28 sec. East** for a distance of **14.71 feet** to 86.83 feet left of the existing centerline of right-of-way of Refugee Road at station 89+88.55;

**THENCE South 22 deg. 49 min. 42 sec. East** for a distance of **13.30 feet** to 75.00 feet left of the existing centerline of right-of-way of Refugee Road at station 89+94.62;

**THENCE North 85 deg. 40 min. 59 sec. West** for a distance of **5.90 feet** to 75.00 feet left of the existing centerline of right-of-way of Refugee Road at station 89+88.72;

**THENCE North 04 deg. 15 min. 52 sec. East** for a distance of **6.28 feet** to 81.28 feet left of the existing centerline of Right-of-way of Refugee Road at station 89+88.71;

THENCE North 81 deg. 47 min. 11 sec. West for a distance of 85.06 feet BACK TO THE TRUE POINT OF BEGINNING.

The above-described parcel contains 0.044 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-137336.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.
