DESCRIPTION OF 0.001 ACRES

Temporary Easement Kayla Gifford and Ronnie Khoder 1736 E North Broadway

Commencing at a mag nail set in the intersection of existing centerline of right of way for Kenlawn Street (50' width) with the existing centerline of right of way for E North Broadway (50' width);

Thence S 86 degrees 29 minutes 05 seconds E a distance of 162.88 feet with the existing centerline of right of way for E North Broadway to an angle point in said centerline;

Thence S 86 degrees 22 minutes 08 seconds E a distance of 153.77 feet with the existing centerline of right of way for E North Broadway to a point in said centerline;

Thence **N 03 degrees 37 minutes 52 seconds E** a distance of **36.00 feet** across roadway and crossing the existing north right of way line for E North Broadway, and across the grantor's tract (Lot 17) with the west line of an existing easement as described in Instrument Number 201802130021146 to the *TRUE POINT OF BEGINNING*;

Thence continuing N 03 degrees 37 minutes 52 seconds E a distance of 1.00 feet across the grantor's tract to a point;

Thence S 86 degrees 22 minutes 08 seconds E a distance of 18.38 feet across the grantor's tract to point in the west line of Lot 16 of said plat and described in a deed to R.E. Barrie, LLC by deed of record in Instrument Number 200903270042885, same also being the east line of the grantor's tract (Lot 17);

Thence **S 03 degrees 37 minutes 52 seconds W** a distance of **1.00 feet** with the west line of R.E. Barrie tract (Lot 16) and the east line of the grantor's tract (Lot 17) to the northeast corner of said existing easement;

Thence N 86 degrees 22 minutes 08 seconds W a distance of 18.38 feet across the grantor's tract (Lot 17) with the north line of an existing easement to the *TRUE POINT OF BEGINNING*; containing 0.001 acre (18.38 sq. ft.) of land more or less.;

The above described area contains a total of **0.001 acres** (**18.38 sq. ft.**) within Franklin County Auditor's Parcel Number 010-071168-00, which includes 0.000 acres in the present road occupied.
