

BACKGROUND:


- The site is developed with a vacant commercial building in the L-C-4, Limited Commercial District. The applicant is requesting the CPD, Commercial Planned Development District (Subarea A) to permit an automatic car wash and the L-C-4, Limited Commercial District (Subarea B) to permit future commercial development.
- The site is surrounded by commercial development in the C-4, Commercial or L-C-4, Limited Commercial District.
- The site is subject to the South High Street RCO and is located within the boundaries of Scioto Southland Plan (2007), which recommends "Commercial" land uses for this location.
- The site is located within the boundaries of the Far South Columbus Area Commission, whose recommendation is for approval.
- The development text commits to a site plan and includes development standards addressing site access, landscaping, and graphics provisions. For Subarea A, a variance to drive-up stacking area is included in this request.
- The *Columbus Thoroughfare Plan* identifies South High Street as a 4-2D arterial requiring a minimum of 60 feet of right-of-way from centerline.


<u>CITY DEPARTMENTS' RECOMMENDATION</u>: Approval.

The requested CPD, Commercial Planned Development and L-C-4, Limited Commercial Districts will allow a car wash and future commercial development that is compatible with the density and development standards of adjacent commercial development. The proposed car wash in Subarea A and permitted uses of Subarea B are compatible with the land use recommendation of the *Scioto Southland Plan* as well as RCO standards.
