Thence South 85° 32' 20" East, following the centerline of Groves Road, the southerly line of said Half Section 36 and the northerly line of Half Section 49, for a distance of 75.00 feet to a 0.092 acre tract as described in a deed to Eastland Investment Co. in Deed Volume 3153 page 519 and having a station 107+75.00 of Groves Road:

Thence South 04° 22' 11" West, leaving the centerline of Groves Road, following the westerly line of said 0.092 acre tract and then the westerly line of a dedicated portion of right of way of Groves Road to the City of Columbus in Deed Book 2708 page 488, for a distance of 30.00 feet to the intersection of the easterly right of way of Hamilton Road, conveyed as Parcel 54B-WD to the State of Ohio in Deed Book 2642 page 447 and as shown in FRA-40-18.69/FRA-317-2.05 and the southerly right of way of Groves Road and the northwesterly corner of said 0.7346 acre tract and being the **True Place of Beginning** of the parcel here in described;

Thence South 85° 32' 20" East, following the southerly right of way Groves Road and the northerly line of said 0.7346 acre tract, for a distance of 199.83 feet to <sup>3</sup>/<sub>4</sub>" iron pipe found at the northeasterly corner of said 0.7346 acre tract and northwesterly corner of a 2.532 acre tract as described in a deed to SYLVESTRE EASTLAND, LLC in Instrument Number 201504290054899;

Thence South 04° 16' 56" West, following the easterly line of said 0.7346 acre tract and the westerly line of said 2.532 acre tract, for a distance of 5.50 feet to a point;

Thence passing through said 0.7346 acre tract for the following three (3) courses and distances;

- 1. North 85° 32' 20" West, for a distance of 168.32 feet to a point;
- 2. South 70° 00' 17" West, for a distance of 22.34 feet to a point;
