The Henderson Road booster station is over 50 years old and many components have reached the end of their service life. This booster station serves the Henderson Pressure District (Northwest portion of the City). The booster station will be renovated and improvements will include: changing out the pumps, motors, valves and electrical equipment, new roof and an electrical room addition.

This is the first renewal to the contract.

This contract renewal is for the Operations and Maintenance (O&M) Ready process and engineering services during construction. The City's Operations and Maintenance (O&M) Ready process provides for the O&M personnel to be fully informed and have the necessary information to immediately begin O&M on equipment upon turnover to the City. The Consultant's responsibilities for the O&M ready process will include gathering all necessary O&M data, inputting data into spreadsheets/templates so that information can be imported into Department of Public Utilities' Oracle WAM computerized maintenance management system. Services during construction include review of construction submittals/shop drawings and reviewing and responding to contractor requests for information (RFIs). The final design has resulted in a complex construction project with a significantly greater number of submittals and RFIs than anticipated in scope of original agreement.
