The undersigned, Epcon Riverside, LLC, an Ohio limited liability company, by Authorized Signatory for the lands platted hereon, duly authorized in the premises, does hereby certify that this plat correctly represents The Courtyards on Riverside, a subdivision containing Lots numbered 1 to 81, inclusive, and Reserves A to I inclusive, and does hereby accept this plat of the same and does dedicate that portion of Riverside Drive in fee, as represented herein to the public.

Easements are hereby reserved in, over and under areas designated on this plat as "Sanitary Sewer Easement" and "Reserve 'A". Each of the aforementioned designated easements and reserves permit the construction, operation and maintenance of all public and quasi-public utilities above, beneath, and on the surface of the ground and, where necessary, for the construction, operation and maintenance of service connections to all adjacent lots and lands. Within said "Reserve 'A", a non-exclusive easement is hereby granted to the City of Columbus and other governmental employees or licensees for use in the course of providing police, fire, medical or other government services to lots and lands adjacent to said "Reserve 'A". Furthermore, in accordance with the terms and regulations of Section 3123.08(c)(8) of the Columbus City Codes 1959, there is hereby offered an easement to the cable television industry for the installation, operation and maintenance of television cable and equipment. Easement areas shown hereon outside of the platted area are within lands owned by the undersigned and easements are hereby reserved therein for the uses and purposes expressed herein.

construction/installation of the street pavement and utilities.


