The goal of this project is to replace the existing 2-inch, 6-inch and 8-inch water lines that have a high break frequency. Replacement of these lines will improve water service, decrease burden on water maintenance operations, and reduce water loss.

Work consists of installation of approximately 11,400 linear feet of 2-inch, 6-inch, and 8-inch water mains, and other such work as may be necessary to complete the contract.

The Department of Public Service will also be contributing funds to provide additional pavement resurfacing (north lane of Dibblee Avenue from N. Powell Avenue to western terminus) as part of the project.

Planning Areas: "53 – Greater Hilltop" planning area and includes the following streets: Orel Avenue, Steele Avenue, Sutton Avenue, Carol Avenue, Westwood Drive, Dibblee Avenue, N.
