Situated in the State of Ohio, City of Columbus, Franklin County, Half Section 27, Township 5, Range 22, and part of a 44.960 acre tract conveyed to State of Ohio, with the Canal Lands Act of 1825 and leased to Columbus and Southern Ohio Electric Company in Lease Record 83, Page 346, as recorded in the Franklin County Recorder's Office. The below described parcel laying on the right and left side of the proposed centerline of right of way for Short Street in project SHORT STREET as platted by 2LMN, Inc. as recorded in Plat Book 127, Page 84-85, and being more particularly described as follows:

COMMENCING at a $5 / 8$ inch iron pin found on the north existing right of way for Sycamore Street, dedicated to the City of Columbus in Instrument 200410220245227 and the east line of the grantor's tract, also being the southwest corner of a 7.703 acre tract conveyed to The Kroger Co., an Ohio Corporation as recorded in Instrument Number 200503290057421, said pin being 38.59 feet right of centerline of Short Street at station 10+22.70 and being the TRUE POINT OF BEGINNING for the parcel herein described:

2) Thence, along the east proposed standard highway easement for Short Street with a curve to the right having a radius of 96.50 feet, a central angle of 72 degrees 44 minutes 45 seconds, an arc length of 122.52 feet, and a chord that bears North 54 degrees 10 minutes 29 seconds West, 114.46 feet, to an iron pin set, said pin being 23.50 feet right of the centerline of Short Street at station 11+69.76;
3) Thence, along the east proposed standard highway easement for Short Street, North $\mathbf{1 7}$ degrees 48 minutes 07 seconds West, 267.52 feet to an iron pin set, said pin being 23.50 feet right of the centerline of Short Street at station 14+37.28;
