Re: Refund of Dublin's Sanitary Sewer Capacity Fees

The Glens @ Ballantrae

Cottages @ Ballantrae Woods

Deer Run

Attached is the documentation and request for a refund of the City of Dublin's sanitary sewer capacity fees in the amount of \$250,620 that were inappropriately paid to the City of Columbus.

The City of Dublin created three master meter subdivisions referenced above. Dublin owed Columbus for three master sanitary sewer connections (one for each of the three subdivisions). Dublin properly paid for two master sanitary connections (The Glens @ Ballantrae, \$32,472 paid 10/14/16, ALE#12589 and Cottages @ Ballantrae Woods, \$50,737 paid 10/14/16, ALE#12589). Additionally, Dublin improperly paid for numerous single family connections within all three of these subdivisions.

The sewer capacity fees that Dublin paid for the single connections need refunded. These fees were collected over a period of four years (2016, 2017, 2018 and 2019).

The next three tables display what was owed to Columbus, what was paid by Dublin, what has already been refunded to Dublin and what still needs refunded to Dublin.
