Thence North 82° 13' 48" West, across said Lots 62 through 67, inclusive, with the line common to said CHI FRANKLINTON tract and said 0.050 acre tract, a distance of 165.44 feet to a 5/8-inch iron rebar capped "COLUMBUS R/W" found at the common corner thereof and at a common corner of that tract conveyed to the City of Columbus, Ohio by deed of record in Deed Book 1660, Page 530 and that tract conveyed to New York Central Lines by deed of record in Instrument Number 200212180325201, located 48.50 feet left of the existing centerline of right-of-way of McKinley Avenue station 46+24.94;

South 83° 14' 30" West, a distance of 31.42 feet to an iron pin set, located 35.88 feet left of the existing centerline of right-of-way of McKinley Avenue station 48+41.94;

North 83° 39' 56" West, a distance of 51.93 feet to the TRUE POINT OF BEGINNING, containing 0.055 acre, more or less, from Auditor's Parcel Number 010-000423.

Iron pins set, where indicated, are iron pipes, thirteen sixteenths (13/16) inch inside diameter, thirty (30) inches long with a plastic plug placed in the top bearing the initials EMHT INC.

The bearings herein are based on the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Control for bearings was from coordinates of monuments "COC 13-83" and "COC 1-83", having a bearing of North 72° 45' 54" East, as established by the Franklin County Engineering Department.
