Contract work is required to be completed in a manner acceptable to the City within 730 days from the date that a Notice To Proceed (NTP) is given by the City. The City anticipates issuing a Notice to proceed on or about September of 2020.

These contracts will provide assistance to our water line maintenance crews in completing water main break repairs in a timely matter should the number of breaks exceed our normal maintenance capacities.

The bid amount and proposed award amount is \$626,576.50 for Travco Construction, Inc. and \$632,956.50 for John Eramo & Sons, Inc., including a 10% construction contingency amount that will be utilized to fund needed and approved changes in the work. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
