South 74°00'54" West, 16.46 feet to a point, being on the easterly line of a 0.531 acre tract conveyed to Richard L. Sarolberry and Rena L. Sarolberry in Official Record Volume 17031 Page H08;

Thence along the easterly line of said 0.531 acre tract and the westerly line of said 2.0449 acre tract, North 13°45'50" East, 28.79 feet to a point;

Thence across said 2.0449 acre tract, the following two (2) courses:

North 74°00'54" East, 15.89 feet to a point;

South 48°29'03" East, 153.80 feet to a point, said point being the **POINT OF TRUE BEGINNING**, containing 0.097 acres (4,243 S.F.), more or less.

Subject however to all legal easements, restrictions and rights of way of record and of records in the respective utility offices.
