As I mentioned to you earlier this year, we plan to split this year's EcoSmart grant between a Payment Assistance Program (Covid and Low Income) and a Department of Development C-Pace Program. We have been advised to get AMP's permission to allow the city to contract with a third party, "The Finance Authority", to disburse the C-Pace funds.

In essence, \$76,143 will be transferred to our Development Department's Finance Authority to administer their C-Pace program which will fund Division of Power customers installing energy efficiency projects.
