Thence South 87°27'59" East, leaving said right of way line and proceeding for a distance of 60.00 feet to a point on the westerly line of said 49.049 acre tract, being a common line with the easterly right of way line of said Logistics Court;

Thence South 87°27'59" East, across said 49.049 acre tract, for a distance of 30.00 feet to a point on an easterly line of an existing 30.00 foot Easement of record, said point being the **TRUE POINT OF BEGINNING**;

Thence North 02°32'01" East, through said 49.049 acre tract and along said existing easement line, for a distance of 60.01 feet to a point;

Thence South 86°42'33" East, through said 49.049 acre tract, for a distance of 51.77 feet to a point;

Thence South 86°42'24" East, through said 49.049 acre tract, for a distance of 1494.29 feet to a point on the easterly line of said 49.049 acre tract and the westerly line of a 11.033 acre tract conveyed to Hart Columbus Logistics LLC by deed of record found in OR Volume 767, at Page 5278, which is a common line to Harrison Township Section 13, Township 3, Range 22 and Madison Township Section 18, Township 10, Range 21;

Thence South 03°47'34" West, along the easterly line of said 49.049 acre tract and the westerly line of said 11.033 acre tract, which is a common line between Harrison Township Section 13, Township 3, Range 22 and Madison Township Section 18, Township 10, Range 21, for a distance of 60.00 feet to a point on said common line;

Thence North 86°42'24" West, through said 49.049 acre tract, for a distance of 1493.77 feet to a point;
