Being a parcel of land lying on the left side of the existing centerline of right-of-way of Hudson Street (R/W Varies – Public) and being more particularly described as follows:

COMMENCING FOR REFERENCE at a Mag Spike set at the southeast corner of the Grantor, the southwest corner of that tract conveyed to Goldman Properties by the instrument filed as Instrument Number 200512070258131, on the centerline of right-of-way of Hudson Street, and on the southerly line of the said Lot 5, said spike being at station 54+59.83;

Thence along the easterly line of the Grantor and the westerly line of the said Goldman Properties tract, **North 03 degrees 42 minutes 26 seconds East for a distance of 30.00 feet** to a 1" iron pipe found on the existing northerly right-of-way line of Hudson Street, said pipe being 30.00 feet left of the centerline of right-of-way line of Hudson Street station 54+59.83, said pipe being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence crossing through the lands of the Grantor and along the said existing northerly right-of-way line of Hudson Street, **North 86 degrees 17 minutes 34 seconds West for a distance of 58.41 feet** to a point at an angle point in the said existing northerly right-of-way line of Hudson Street, at a westerly corner of the Grantor, and at the easterly corner of that 0.0368 acre tract as conveyed to City of Columbus, Ohio by the instrument filed as Instrument Number 200004130071864, said point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 54+01.42;

- 3. South 53 degrees 07 minutes 36 seconds East for a distance of 31.79 feet to a point being 42.33 feet left of the centerline of right-of-way of Hudson Street station 53+90.78;
- 4. North 61 degrees 25 minutes 39 seconds East for a distance of 18.11 feet to a point being 52.00 feet left of the centerline of right-of-way of Hudson Street station 54+06.10;

The bearing for this description are based on Grid North as referenced to South 86 degrees 18 minutes 11 seconds East for the centerline of right-of-way of Hudson Street east of Interstate Route 71 (FRA-1-25.33) as referenced to the Ohio State Plane coordinate system (South Zone) and the North American Datum of 1983, as established utilizing a GPS survey and NGS OPUS solution.
