Situated in the State of Ohio, County of Franklin, City of Columbus, Clinton Township, being in Quarter Township 4, Township 1 North, Range 18 West of the United States Military Lands, being part of Lot 3 of Homestead Heights as recorded in Plat Book volume 15, page 7 (all document references are to the records of Franklin County unless otherwise stated), and being a 0.001 acre parcel out of that tract known as Franklin County Auditor's **Parcel Number 010-075341** as conveyed to **Central Congregation of Jehovah's Witnesses**, **Columbus, Ohio, an Ohio Corporation** (hereafter referred to as "Grantor") by the instrument filed as **Instrument Number 201210170156684.** 

Being a parcel of land lying on the right side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

**COMMENCING FOR REFERENCE** at a 1" iron pin set in a monument box on at an angle point in the centerline of right-of-way of Hudson Street, being the southeast corner of Lot 5 of the Partition of Casper Kiner's Heirs as recorded in Deed Book volume 326, page 464, the southwest corner of Highway Park Extension as recorded in Plat Book volume 17, page 354, and being on the northerly line of Grasmere Gardens as recorded in Plat Book volume 15, page 2, said pin being at station 61+45.69 of the said centerline of right-of-way of Hudson Street;

Thence along the said centerline of right-of-way of Hudson Street, **South 86 degrees 36 minutes 37 seconds East for a distance of 138.25 feet** to a point being at station 62+83.94 of the centerline of right-of-way of Hudson Street;

Thence leaving the centerline of right-of-way of Hudson Street perpendicularly, **South 03** degrees 23 minutes 23 seconds West for a distance of 30.00 feet to a point at the Grantor's northeast corner, the northeast corner of the said Lot 3, and being at the intersection of the existing southerly right-of-way line of Hudson Street and the westerly right-of-way line of Gerbert Road (50' R/W – Public), said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 62+83.94, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the Grantor's easterly line, the easterly line of the said Lot 3, and the said westerly right-of-way line of Gerbert Road, **South 03 degrees 21 minutes 16 seconds West for a distance of 4.00 feet** to a point being 34.00 feet right of the centerline of right-of-way of Hudson Street station 62+83.94;

Thence crossing through the lands of the Grantor and through the said Lot 3, North 77 degrees 25 minutes 53 seconds West for a distance of 25.08 feet to a point on the Grantor's northerly line, the northerly line of the said Lot 3, and on the said existing southerly right-of-way line of Hudson Street, said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 62+59.19;
