Being a parcel of land lying on the left side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

Thence crossing through the lands of the Grantor and through the said Lot 7, North 17 degrees 04 minutes 27 seconds East for a distance of 13.65 feet to a point on the Grantor's easterly line, the easterly line of the said Lot 7, and on the said westerly right-of-way line of Ontario Street, said point being 43.26 feet left of the centerline of right-of-way of Hudson Street station 66+01.53;
