Clark** (hereafter referred to as "Grantor") by the instrument filed as **Instrument Number 200805130073722.** 

Being a parcel of land lying on the right side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

**COMMENCING FOR REFERENCE** at a 1" iron pin set in a monument box on at an angle point in the centerline of right-of-way of Hudson Street, being the southeast corner of Lot 5 of the Partition of Casper Kiner's Heirs as recorded in Deed Book volume 326, page 464, the southwest corner of Highway Park Extension as recorded in Plat Book volume 17, page 354, and being on the northerly line of Grasmere Gardens as recorded in Plat Book volume 15, page 2, said pin being at station 61+45.69 of the said centerline of right-of-way of Hudson Street;

Thence along the said centerline of right-of-way of Hudson Street, **South 86 degrees 36 minutes 37 seconds East for a distance of 813.06 feet** to a point being at station 69+58.75 of the centerline of right-of-way of Hudson Street;

Thence along the Grantor's northerly line, the northerly line of the said Lot 16, and the said existing southerly right-of-way line of Hudson Street, **South 86 degrees 36 minutes 37 seconds East for a distance of 19.10** feet to a point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 69+77.85;

Thence crossing through the lands of the Grantor and through the said Lot 16, South 84 degrees 02 minutes 38 seconds West for a distance of 19.36 feet to a point on the Grantor's westerly line, the westerly line of the said Lot 16, and on the said easterly right-of-way line of Homestead Drive, said point being 33.14 feet right of the centerline of right-of-way of Hudson Street station 69+58.75;
