Being a parcel of land lying on the right side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

COMMENCING FOR REFERENCE at a 1" iron pin set in a monument box on at an angle point in the centerline of right-of-way of Hudson Street, being the southeast corner of Lot 5 of the Partition of Casper Kiner's Heirs as recorded in Deed Book volume 326, page 464, the southwest corner of Highway Park Extension as recorded in Plat Book volume 17, page 354, and being on the northerly line of Grasmere Gardens as recorded in Plat Book volume 15, page 2, said pin being at station 61+45.69 of the said centerline of right-of-way of Hudson Street;

Thence along the Grantor's easterly line, the easterly line of the said Lot 21, and the said westerly right-of-way line of Medina Avenue, **South 03 degrees 22 minutes 44 seconds West for a distance of 6.32 feet** to a point being 36.32 feet right of the centerline of right-of-way of Hudson Street station 72+17.06;

Thence crossing through the lands of the Grantor and through the said Lot 21, North 68 degrees 48 minutes 42 seconds West for a distance of 20.67 feet to a point on the Grantor's northerly line, the northerly line of the said Lot 21, and on the said existing southerly right-of-way line of Hudson Street, said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 71+97.38;
